UBC is recognized as a top employer. With over 70,000 students, almost 19,000 employees, and an annual operating budget of \$3.4 billion, UBC provides a rich and complex environment in which to pursue a career. The OUC is responsible for managing all of UBC's legal affairs (with the exception of labour and employment matters) and provides a supportive and collegial work environment. The OUC is seeking a highly qualified individual to serve as Legal Counsel for a 12-month term. This individual will provide legal advice and services to UBC, focusing primarily on solicitor's work.

The successful candidate will:

- provide legal advice and services on a range of legal issues directly to faculties and administrative units (except with respect to labour and employment matters);
- negotiate, draft, and review a broad range of legal documentation, including agreements to which UBC is a party, with a view to ensuring consistency in external dealings and compatibility with UBC's policies and objectives;
- approve indemnities as authorized by the Ministry of Finance;
- coordinate the development and review of internal regulatory instruments issued by the Board of Governors and Responsible Executives;
- identify and recommend procedures and practices to protect UBC from undue liability;
- subject to the approval of the University Counsel, retain, instruct, and supervise external legal counsel on behalf of UBC: and
- participate in the provision of training and other educationoriented initiatives on legal issues affecting UBC.

The ideal candidate must:

- be a member in good standing of the Law Society of British Columbia;
- have a law degree and broad-based experience as a practising lawyer, preferably including 5 years of solicitor's experience;
- have a strong grounding in corporate law, commercial transactions, contract drafting and interpretation, and regulatory drafting and interpretation;
- have strong analytical skills, including the ability to work from first principles in the absence of precedents;
- have strong interpersonal skills, including the ability to relate well with faculty, staff, and students;
- be an effective presenter and negotiator;
- have the demonstrated ability to exercise judgement, tact, and discretion;
- have extremely effective oral and written communications skills;
- have the ability to simultaneously manage a diverse range of complex projects and activities;
- be willing to respect diverse perspectives, including perspectives in conflict with one's own; and
- be committed to enhancing one's own awareness, knowledge and skills related to equity, diversity and inclusion.
